**MET 2024 Test Details**

- Test Duration: **120** minutes
- Total Questions: **100** covering Numeracy (20 questions), Conceptual (30 questions), English (20 questions), General Awareness (20 questions), Reading Comprehension (10 questions).
- Max Marks: **400**
- Marking Scheme: **+ 4** for every correct answer, **-1** for every wrong answer, **0** for every unanswered question
- By default, MET 2024 Test fee (Rs.1,400) is collected along with the application fee at the time of Online Application submission.

**MET 2024 Attempt Details**

No. of Attempts: **2**

At the time of Online application submission (<https://apply.manipal.edu>) all candidates are requested to select any 3 Tentative Test center cities in the order of Preference / Priority. Most preferred City to be selected under “Tentative Test Center City (Preference 1)”. All efforts will be made to allot the Preference no.1 city. However, due to administrative / logistic reasons, the University may allot a Preference no.2 city / Preference no. 3 city.

In case of unavailability of the Test Center at a particular city, the University reserves the right to allot a city other than the candidate’s Preferred Test Center cities. The decision of the University regarding the allotment of the Test Center City shall be final. No further correspondence or request shall be entertained in such a case.

Hence, while filling up the Online Application Form, candidates **MUST** select the most Convenient City as per Preference / Priority from the list of Exam Center cities made available. MAHE will not be responsible for any inconvenience due to the incorrect selection of city by the candidates.

All applicants can book their entrance test slots (**Date & Batch**) in the Online Test Booking System (OTBS) based on the availability of seats. There is **NO** provision for selecting the City at the time of Online Test Booking.

**Guidelines for 1<sup>st</sup> Attempt Booking**

- The bookings (Date & Batch) are done on a first come first serve basis and are subject to the availability of seats.
- A slot once booked cannot be changed. Requests for the change of test center city / date / slot will not be entertained under any circumstances. **Hence, you are requested to book your slot, avoiding all other Central / State Entrance tests.**

It is the responsibility of the candidates to book their test schedule. MAHE will not be held accountable for the non-bookings.

### Guidelines for 2<sup>nd</sup> Attempt Booking

- Candidate will be allowed to take second attempt if s/he is not satisfied with his/her performance in the first test, subject to availability of seats. The second slot may be booked after the first attempt as per the schedule mentioned above.
- Candidates applying **on or before** the last date applicable for 1<sup>st</sup> attempt will be eligible for a second attempt with an additional fee payment of Rs.1400, in Phase 2
- Candidates giving the first attempt in Phase 2 are NOT eligible for a second attempt in Phase 2
- Based on the above-mentioned eligibility, the candidate can go for the second attempt by making an online payment of Rs.1400/- in OTBS, subject to the availability of seats. There is no need of applying afresh under <https://apply.manipal.edu>
- **Test Center City for the second attempt is as same as the City for the first attempt.** In case of unavailability of the Test Center at the same City, the University will identify the Test Center at the nearby City.
- The bookings are done on first come first serve basis and are subject to availability of seats.

A slot once booked for cannot be changed. Requests for the change of test center / date / slot will not be entertained under any circumstances. **Hence, you are requested to book your slot, avoiding all other Central / State Entrance tests.**

### Numeracy

Number system, BODMAS rules, Averages, Ratio and Proportion, Percentages, Time and distance, Mixture and fraction, Cost & Pricing, Direction and dimensions, Age and puzzle. Number series etc

### Conceptual

General business awareness and understanding of business functions, financial services, banks, financial scams, economics, Corporate who's who; punchlines, and taglines.

Student's ability to recall and relate to brands, names, personalities and biz news is tested.

### English

Test candidate's reading ability and level of Grammar: Spotting Errors, Sentence Improvements and completions, Tenses, Conjunction, synonyms etc

### General Awareness / General Knowledge

Test candidate's general awareness and current affairs: History, Civics, Space, Personalities - Field, Famous days, Legal, Trade, Business, General awareness and current affairs, day to day science etc

### Reading Comprehension

Reading comprehension section tests candidate's ability to process a written text, understand its meaning, and to reflect critically on the assumptions. It involves the process of reading and language comprehension. The readers are tested on their ability to

interpret the given text (a short passage), make deductions, and infer the meaning. This section evaluates candidate's skills such as factual, inferential, and global comprehension, identifying main ideas and supporting details, and deducing meaning out of the written text.
