INDIA'S FIRST

The Indian construction sector is growing exponentially. Infrastructure investments are poised to reach US\$ 1.3 trillion (INR 104.2 Trillion) in the next four years. National Highways, Airports, Railways and Ports are the key growth drivers.

This rapid growth creates the need for trained Construction Law professionals, who have the requisite knowledge and expertise to focus on contract management and dispute resolution.

Astute contract management, best procurement practices, risk identification and mitigation strategies, cost management and control, accurate scheduling and monitoring to avoid expensive delays, effective claims management and swift dispute resolution are the need of the hour! This presents the opportunity for legal experts, engineers, surveyors and lenders, to level up with specialized training in arbitration for infrastructure projects.

However, until now there are no academic programmes in India offering specialization in Construction Law and Arbitration at the Masters level (LLM).

To bridge the skills gap, the Manipal Law School at Manipal Academy of Higher Education, Bengaluru campus (MAHE B'LRU) is pioneering India's first industry specific programmes in Construction Law and Arbitration, in association with an international consultancy C Cubed Consultants Ltd.

Non-legal professionals will be taught law subjects related to construction, while the legal professionals will be taught engineering topics related to construction.
