Preamble:

In the Government letter dtd.13.4.87 cited above, Govern-  
ment had stated to Medical Director,KMC,Mangalore that they  
have no objection to the starting of a Dental Degree course  
at Mangalore from the academic year 1986-87 subject to his  
furnishing the report of the Mangalore University and obtain-  
ing the approval of the Dental Council of India.

In his letter dtd. 4.7.87 cited at(2) above, the Medical  
Director, K.M.C.Manipal has stated that because of the delay  
in their admissions during 1986-87//set off by the University  
against the intake for the academic year 1987-88 and hence he  
has requested that the intake to the BDS Course at K.M.C.Manga-  
lore be increased to 100 for the academic year 1987-88, so that  
besides accommodating the 50 students admitted last year, 40  
students could be admitted for this academic year.

In the Government letter dtd.19.9.87 the Vice Chancellor  
of Mangalore University had been requested to take necessary  
action to fix the intake for this course.

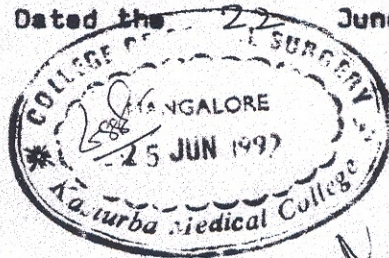

In this connection, it is to be stated that the General Body of the Dental Council of India at its meeting held on 13th & 14th May, 1992 at New Delhi considered your letter referred to above thereby furnishing the 'Compliance Report' of the Council's Visitor Dr. N.S. Yadav of Hyderabad and Council's Inspector Dr. Hari Prakash of New Delhi to evaluate the standard of the final BDS Examination conducted by the Mangalore University in respect of BDS Students of the College of Dental Surgery, K.M.C., Mangalore.

The Council after some discussion accepted the following recommendations of the E.C. (March, 1992) thereon :-
